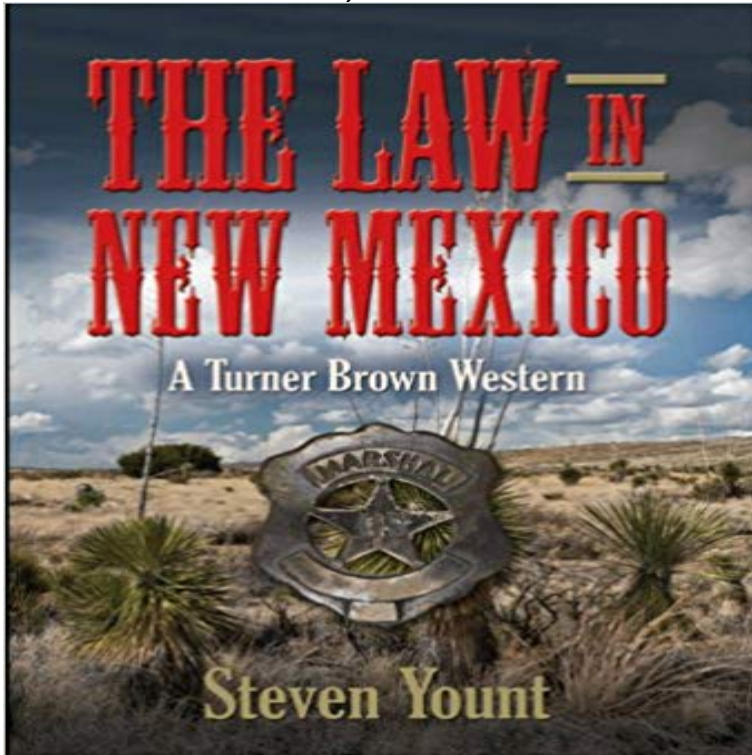


The Law In New Mexico: A Turner Brown Western (Turner Brown Westerns Book 3)
