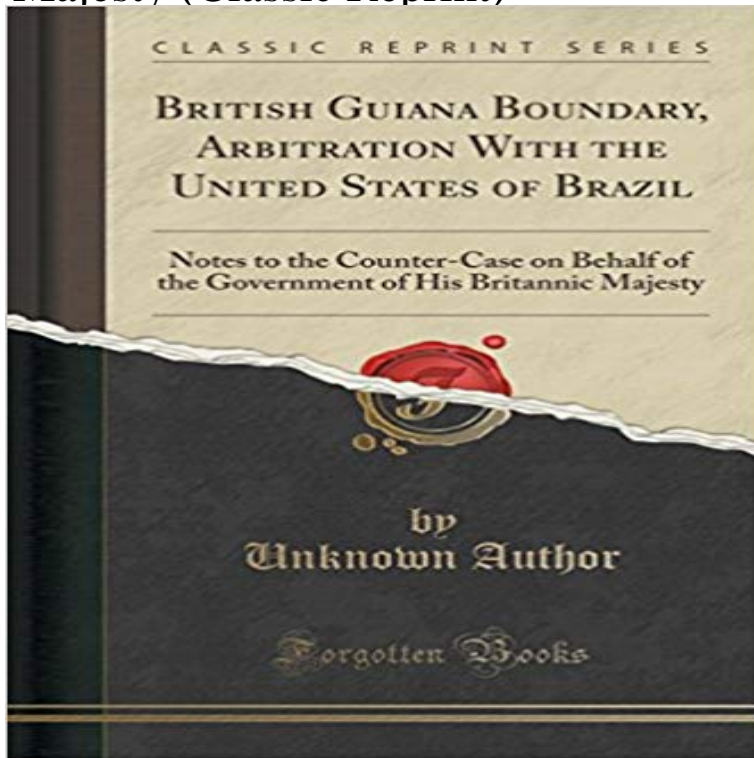

In the year 1740 a Company ascended the river [Branco], in command of Francisco Xavier de Andrade, one of the leader of the expedition commanded by Lourenco Belforte, who established his camp at a short distance from the cataract of the said Uraricoera, from which place he sent out picked bodies, who succeeded in making a journey of two months duration up along the bank of that river in such a manner that they traversed all the extensive plains which surround this river.
